Program Update

Jamey Robinson thanked the Commission for the opportunity to serve Jasper County. Robinson has been meeting with departments within the County and will be reaching out to the elected officials after the first of the year. He is gathering input to present a list of ideas to the Commission at a meeting in February/March for approval of what the EMA program should offer.

- Budget Workshop FY24-25 Robinson explained there is no change in the overall budget. Salary increases for Josh Harding and Kathy Ellis are based upon the 4.95% increase offered to Robinson as part of the hiring process.
 - Change \$8,000 Expense/Revenue Training/Reimbursement examples FEMA trainings (reimbursed) and local CPR classes. We need a line item for that.
 - Local Emergency Planning Grant Utilize grant money if received.

- Capital expenditures are based upon the ten-year Capital Expense Plan for FY25. (Reference your packets for descriptions)
 - EOC Equipment
 - o Copier/Printer
 - Haz Mat Foam Trailer–REG donation / foam component?
 - All donated, reallocate the funds for EMS supplies to make the 701 vehicle (Tahoe) a paramedic car.
 - Chief Wellik provided an example of utilizing the trailer and cost recovery for the foam.
 - Ice Machine
 - Heavy Rescue Trailer
- Revenues are all the same with the addition of the EMPG, comes out as LEPG and training reimbursements.
